<b>Living Costs</b>	The estimated cost of living in Izmir is about 500 Euros/month (including accomodation)
<b>Visa Requirements</b>	Please find the visa requirements from the Turkish Embassies in your own country. All students need to take education visa. Please avoid entering with tourist visa in order to prevent any residence problems.
<b>Facilities</b>	Library, Fitness Centre, Sporting Service, Student Clubs, Health Services, free internet access in the campus.

<b>Health Insurance</b>	<p>In line with the new Turkish regulation on residence permits, all Erasmus students are required to obtain a general Health Insurance which is valid in Turkey with specific conditions laid down in the new regulation. Erasmus students that are entitled to medical assistance in their home countries and coming from countries which social security agreements with Turkey are eligible for health benefits within the framework of these agreements.</p> <p>Erasmus Students are eligible to use the health benefits on the condition that they should receive a “Right to Health Assistance Certificate(formularies)” from the social security institution in their home countries (which have signed a social security agreement with Turkey) and send to Yasar University and to the provincel directorate of social security that the students reside in.</p> <p>List of the countries who have the health agreements with Turkey are as follows:</p> <ul style="list-style-type: none"> <li>• Germany: T/A 11, T/A 9, T/A 20 ,</li> <li>• The Netherlands: N/TUR 106, N/TUR 111, N/TUR 121</li> <li>• Belgium: BT.8, BT 16</li> <li>• Australia: A/TR 3, A/TR 4</li> <li>• Romania: R/TR 3, R/TR5, R/TR 6</li> <li>• Bosnia-Herzegovina: BH/TR 4, BH/TR 6, BH/TR 7</li> <li>• The Czech Republic: CZ/TR 111</li> <li>• Macedonia: MC/TR 4, TR/MC 6</li> <li>• Luxembourg: TR/L 3, TR/L 5</li> <li>•Albania: AL/TR 4, TR/AL 5</li> </ul> <p>The students from other countries that do not have a social security agreement with Turkey <u>should not issue</u> any insurances for their Erasmus period in their home countries but they should issue their Health Insurances after their arrival to Izmir. This is because most of the health insurances issued abroad are not recognized here on the basis of not to include the specific conditions laid in the new law.</p> <p>Yaşar University will assist Erasmus Students to apply for the valid insurance after students’ arrival to Yaşar University.</p>
